Abundant Supply fresh air and call for doctor.

If unconscious, place and transport in stable lateral position.

Immediately dexamethasone spray (Auxiloson, Pumocrt) inhale. Patient to fresh air, seek medical attention Inhalation.

- · After skin contact: Immediately wash with water and soap and rinse thoroughly.
- · After eye contact:

Rinse opened eye for several minutes under running water and seek medical advice.

Eye for several minutes under running water with eyelids open. If symptoms persist, consult a doctor. Unaffected eye protect, remove contact lenses.

- · After swallowing: Drink plenty of water and provide fresh air. Call for a doctor immediately.
- · Information for doctor:

Symptoms: After prolonged exposure to mild skin irritation possible. With aspiration can occur edema and pneumonia.

Irritating: on the skin and mucous membranes, has a narcotic effect. Decontamination, symptomatic treatment. After swallowing Induce vomiting or gastric lavage with enclosing administration of activated charcoal and sodium sulfate (each 1 tablespoon to 1/4 liter of water). Do not give adrenaline or its derivatives. A toxic pulmonary edema can be detected radiographically at an early stage in a chest x-ray about 8 hours after inhalation (perihilar opacities). For comparison, therefore, a chest radiograph is recommended as soon as possible after inhalation, if the risk of pulmonary edema is suspected.
